


Annual Report 2015-16

Action on Disability and Development India is working with a vision of "a world where all persons with disabilities enjoy their rights and are able to participate as fully as they choose at every level in society". It is based **ADD INDIA** on the belief that disability work is not merely about enabling persons with disabilities to access their rehabilitation needs but it is also a development and human rights issue. ADD India has been working since 1989 to promote self help and inclusion of persons with disabilities in the activities of the family and community, and to improve the quality of their life. To improve the quality of life of persons with disabilities by their inclusion MISSION and participation in the community and in the development process. 0 To use CBR as a tool to deliver the promises of CRPD by working at the policy and procedural level to ensure that persons with disabilities are included in all development schemes and programmes. To work with federations of persons with disabilities by facilitating and strengthening their capacity to advocate for their inclusion in **STRATEGY** society and in all development activities. In partnership with other organizations by training their workers to undertake disability work with 'an inclusive approach' and later supporting them in the field to implement programmes. By raising awareness in the community about disability and related issues to bring about a positive change in attitude towards persons with disabilities.


Reach of ADD India's Work

MESSAGE FROM THE PRESIDENT

The World Health Organisation and the World Bank estimate that 15 percent (i.e. one billion people) of the world's population has some form of impairment or the other. They also estimate that less than 5 percent of disabled children in developing countries have opportunities for education and rehabilitation.



Among many other pressing priorities, the Indian Government's resource allocation for disability is dismal. In this context, NGOs like ADD India play a vital role in reaching the unreached.

ADD India to date has contributed to improve the quality of life of over one lakh persons with different disabilities in rural south India. Its strategy of influencing existing NGOs and equipping them to work with disabled people has made it possible to have a larger impact than if working directly with individual persons with disability. Over 180 NGO of which many are organizations run by persons with disability themselves, have been influenced and equipped by ADD India to work with disabled people in rural areas.

This feature singles out ADD India's approach that changes can be brought in the lives of persons with disabilities only with their active involvement and participation. It encourages disabled people to form their own organisations at the village level to actively work to get schools to admit disabled children, banks to give loan and governments to provide entitlements like subsides, land, housing, pension, etc. The result is children with disabilities go to school and have rehabilitation services like therapy and assistive devices, young men and women earn a living and lead a life like anyone else in their own villages.

With your help, ADD India can continue and expand this work to reach more persons with disabilities in need.

REPORT OF ACTIVITIES OF 2015 - 16

It was another challenging year for the organization. We continued into our third year of focusing on issues of women and children with disability and to get Disabled Peoples Organisations (DPOs) to work on their rights, needs and concerns.

STRENGTHENING DPOs TOWARDS SELF RELIANCE AND SUSTAINABILITY

Article 8 of UNCRPD

1. States parties undertake to adopt immediate, effective and appropriate measures:

a) To raise awareness throughout society, including at the family level, regarding persons with disabilities, and to foster respect for the rights and dignity of persons with disabilities; b) To combat stereotypes, prejudices

and harmful practices relating to persons with disabilities, including those based on sex and age, in all ADD India has been involved directly in promoting federations of persons with disabilities for their rights in Sidalagatta Taluka (block) of Chikballapur district in Karnataka; in three blocks viz. Kunnandarkoil, Gandarvakottai and Viralimalai of Pudukottai district in Tamil Nadu and in Ernakulum, Trivandrum and Wyanad in Kerala.

Awareness on water and sanitation:

- ▶ 136 villages in two blocks covered through wall writing on the issues.
- Wall writing is done near schools, library, panchayat office, community hall and bus stops.
- Community members come forward and read the wall writings.



Celebration of World Disability Day:

- ▶ DPOs organized rallies, human chain, speeches, sports and games and gave away prizes to children. Assistive devices were given to needy disabled persons.
- Government officials were invited to attend.
- ▶ Donations and support from local community received.
- In Kerala, the three federations sponsored school bags, stationery and an umbrella each for 207 children.

Accessibility in ATMs and banks:

SVAKS federation in Siddlagatta convinced Canara bank to shift to ground floor from first floor ensuring better access to persons with disability and senior citizens.

Libraries for children:

- Libraries set up both by Tamil Nadu and Karnataka federations.
- Managed by members and field staff.
- Panchayats contribute to maintenance of the library.



WORKING WITH CHILDREN

Article 7 of UNCRPD

1. States parties shall take all necessary measures to ensure the full enjoyment by children with disabilities of all human rights and fundamental freedoms on equal basis with other children.

2. In all actions concerning children with disabilites, the best interest of the child shall be a primary consideration

3. States parties shall ensure that children with disabilities have the right to express their views freely on all matters affecting them, their views being given due weight in accordance with their age and maturity, on an equal basis with other children, and to be provided with disability and age-appropriate

The programmes in Karnataka and Tamilnadu have undertaken many activities to reduce the impact of impairments for children. These include support for:

- Therapy interventions and training of family members for 313 children
- A camp for assessment of hearing impairments reaching out to 50 children
- Enrolment in schools/ICDS (Integrated Child Development Services) for 45 children with severe disabilities in the age group of 0 to 6 years and regular training for parents
- Aids and appliances for 23 children
- Surgical interventions for three children

Collaborations were made and support sought for expertise from NGOs like APD, Holy Cross Service Society, Sense International.

To increase the self esteem of children with disabilities, in Karnataka, Children groups have been formed in local schools. They take up issues with authorities such as proper drainage systems and cleanliness in the villages, proper roads and transportation, etc.







Camps for children - 110 children participated and were given a chance to show their hidden talents.

WORKING WITH WOMEN WITH DISABILITIES

- Collectives of 299 women with disabilities were formed.
- Regular meetings held to discuss ways to address issues related to violation of their rights.



SKILLS TRAINING, LIVELIHOOD OPPORTUNITIES AND ACCESSING GOVERNMENT SCHEMES

Both federations have helped a large number of persons with disabilities to access various government schemes and also provide loans.

In Tamil Nadu about 3000 persons with disabilities have accessed schemes worth Rs.97.7 lakhs in the three blocks.

Some details from Karnataka

- > 17 disabled persons in Sidlaghatta accessed financial support of Rs 35,000/- each for livelihood activities.
- Narayanaswami, 35 years old from Ganjigunte village got Rs 1 lakh loan with Rs 25,000/-subsidy from Animal Husbandry department to purchase two cows. He is earning a good income and is repaying the loan regularly.
- Through SC /ST Corporation Venkateshappa 45 years old got Rs 500,000/- grant for his agriculture work. He dug a bore well, got water and is raising vegetables. He is planning to grow fruit trees.
- 19 PWDs got modified two wheeler scooters from MLA fund. This is helping them in their mobility; take up jobs and to improve their livelihood activities.
- Deepa, 35 years old with locomotor disability has a shop in the village selling household items. Her brother used to get items for her from the neighboring village but now Deepa rides the scooter and gets things for the shop on her own. She is independent and happy.
- A tailoring center was opened for women at Sidlaghatta town, where 10 women, including four with disability are learning tailoring. On completion of training they can get support from the government for starting their own shop.
- Bhagyaraj and Channamuthu, both visually impaired persons got a loan of Rs 50,000/- with Rs 10,000/ subsidy. Bhagyaraj used it for his fancy store and Channamuthu used this amount for millet cultivation. Both are repaying the loan regularly.

In Wyanad, Kerala, Jyothis federation organized one day training on Micro financing for 33 DPO members with support from NABARD.

CAPACITY BUILDING OF DPOS AND STAFF OF PARTNER ORGANIZATIONS

Article-27 of UNCRPD 1. States parties recognise the right of persons with disabilites to work, on an equal basis with others; this includes the right to the opportunity to gain a living work freely chosen or accepted in a labour market and work environment that is open, inclusive and accessible to persons with disabilites. States parties shall safeguard and promote the realisation of the right to work, including for those who acquire a disability during the course of employment, by taking appropriate steps, including

ADD India trains staff of partner organisations to undertake disability work. A total of 187 CBR workers were trained in 2015-16 covering Karnataka, Tamil Nadu, Andhra Pradesh, Odisha and Meghalaya.

- 30 staff of partner NGOs in Gulbarga, Karnataka were trained.
- ► 51 DPO leaders and staff of partner NGOs in Kodaikanal and Thriuvallur districts of Tamil Nadu were trained.
- 25 newly recruited staff of RARE, an organization in Sonepur Odisha were trained on identification of disabilities and interventions needed for rehabilitation.



- 28 DPO leaders of AMAPD a federation promoted by Bethany Society in Shillong, Meghalaya, were trained in advocacy, networking and leadership skills.
- ▶ 45 leaders of DPOs of East Godavari district were trained on conducting meetings, financial management, communication, accessing govt schemes, leadership skills and bringing a social change.

Training of teachers:

As a study centre of CBR Network, ADD India conducts training for the B.Ed course on special education, specializing in Visual Impairment. In the year 2015-16, through four sessions, 258 teachers were trained.



As part of Sarva Siksha Abhiyan of Government of Karnataka, ADD India conducts programmes for

- Capacity building of in-service teachers on inclusive education
- Skills to address educational needs of teachers for inclusion of children with disability in schools.
